1. Introduction

The commencement of the new Wholesale Electricity Market (WEM) on 1 October 2023 included the implementation of a Market Power Mitigation Framework. This Framework has been incorporated into the Energy System and Market (ESM) Rules and is further detailed in several WEM Procedures.

Under the Framework, the Economic Regulation Authority must conduct a Portfolio assessment each year, undertaken in two stages.² The first stage assigns registered Facilities to Portfolios based on registration, ownership, or control. The second stage identifies those Portfolios that are material and may exert market power in the Short-Term Energy Market and Real-Time Market.

The ERA's assessment is guided by the method and process outlined in both the ESM Rules and WEM Procedure – Portfolio Determination.³

Allocation to a Material Portfolio places governance obligations on Market Participants with Facilities within a Material Portfolio to maintain certain records. It also places an obligation on the ERA to monitor offers into the Real-Time Market from Facilities within a Material Portfolio. However, the ERA's monitoring and surveillance activities are not confined only to these Facilities.

The ERA's determination process is dependent on the information provided by Market Participants. The WEM Procedure sets a deadline of 1 August each year for Market Participants to provide the ERA with their Declaration of Control for each Facility defined in the ESM Rules.⁴

This document updates the list of identified Portfolios published on 14 October 2025, resulting from a declaration provided by a Market Participant in late October 2025.⁵

1.1 Update to published list of Portfolios

This update is published to meet WEM Rule clause 2.16B.5, introduced in the 20 November 2024 rule changes made by the Coordinator of Energy. This clause requires the ERA to update the published list of each identified Portfolio within 20 business days of receiving a declaration from a Market Participant when:

- A new Scheduled, Semi-Scheduled or Non-Scheduled Facility is registered in the WEM.
- There is a change in the registration, ownership or control (directly or indirectly) of an existing Scheduled, Semi-Scheduled or Non-Scheduled Facility.⁶

Table 1 sets out the list of identified Portfolios from the ERA's most recent Portfolio Determination process (1 October 2025).⁷ This table has been updated as a result of a

declaration provided to the ERA under ESM Rule clauses 2.16B.4(b) and (c) and includes two new Facilities – COLLIE_ESR4 and COLLIE_ESR5 – registered in the WEM since the ERA published its *Portfolio Identification and Material Portfolio Determination* report.⁸

The ERA will allocate these Facilities to Portfolios when it completes its next annual identification of all Portfolios operating in the WEM (1 October 2026). Material Portfolios will also be allocated at this time.
